Sub: Admission in Under Graduate and Post graduate Courses in ASU&H College for academic session 2020-21-reg.

Sir/Madam,

I am directed to refer to the subject cited above and to say that the Ministry has received various representations requesting to reduce the required percentile criteria in the AIAPGET-2020 in order to be eligible for admission in Ayurveda, Siddha, Unani and Homoeopathy (ASU & H) PG courses for academic year 2020-21, due to various reasons.

2. In this regard, the matter has been examined by the Ministry and decided that in order to be eligible for admission in ASU & H PG courses for academic year 2020-21, it shall be necessary for a candidate to obtain minimum marks at 40th percentile in AIAPGET-2020.

However, in respect of candidates belonging to the Schedule Castes, the Scheduled Tribes, Other Backward Classes, the minimum marks shall be at 30th percentile. In respect of candidates with benchmark disabilities specified under the Rights of Persons with Disabilities Act, 2016, the minimum marks shall be at 35th percentile for Un-Reserved (UR) Category and 30th percentile for SC/ST/OBC.

3. Further, Ministry has decided to extend the last date/ cut-off date for admission in ASU & H Under-Graduation and Post-Graduate Courses upto 31st March, 2021 for academic year 2020-21.

4. This clarification is applicable only for academic year 2020-21.

5. This issues with the approval of the competent authority.
